- Any poles rented will be initially inspected by the Dynasty Pole Vault Mid-South, LLC (DPVMS) Pole Rental Agent and the Renter, with any current impairment (i.e. minor scratch, torn/ripped label, etc.) being documented
- Pole(s) will be transported carefully in a pole sock, tube, or pole bag
- During practice and/or competition, pole(s) will never be laid/placed on the ground - Pole(s) will be laid/placed on the pole stand, on a hurdle, or back in the protective tube or pole bag
- Pole(s) will be protected from impacting the standards during practice and/or competitions (cushion standards or teach correct release of pole)
- Avoid bail out(s), run through(s), and dragging the pole up to knock cross bar off
- Any damage (i.e. break, bruise, spike scratch, etc.) to the pole(s) will be immediately reported (text message, email or cellular call) to the DPVMS, Pole Rental Agent. **In the event of any damage (wherein the pole is no longer safe for use), breakage, or theft, the Renter agrees to reimburse DPVMS, LLC 100% of the MSRP and shipping cost(s) for a replacement pole.**
- Pole(s) will NOT be lent/loaned to any other individual, and/or teammate, without prior approval from the DPVMS Pole Rental Agent
- It is the Renter's responsibility to remove any, and all new grip tape (and adhesive) from the pole(s) prior to returning the pole(s) - **failure to do so will result in an additional \$20 cleaning fee per pole** - adhesive can be removed with Acetone (please refer to website for proper cleaning instructions)

- It is the Renter's responsibility to return all pole(s) to DPVMS by the end of business hours on the contractual expiration date (unless prior arrangements have been established) - **failure to do so will result in a late fee of \$5 per day**

- Rented pole(s) will be inspected by the DPVMS Pole Rental Agent and the Renter upon return (in the event of any damage (wherein the pole is no longer safe for use), breakage, or theft, the Renter agrees to reimburse DPVMS, LLC 100% of the MSRP and shipping cost(s) for a replacement pole

- **Renter assumes all risks associated with the use of rented pole(s) and holds the Dynasty Pole Vault Mid-South LLC, and any of its employees, agents, etc., harmless**
